


CITY COUNCIL HIGHLIGHTS

April 5, 2016

PRESENATION OF AWARD FROM CALIFORNIA PARKS AND RECREATION SOCIETY - Agenda Item No. 1

The California Parks and Recreation Society recognized the Lake Forest Sports Park with the 2015 Park Planning Award. The award recognizes excellence in design of public park facilities including high standards in the areas of planning, design, usability, accessibility and versatility. This is the fourth design award the Sports Park has won.

CHANGES TO THE ORANGE COUNTY FIRE AUTHORITY EMERGENCY DEPLOYMENT MODEL IN LAKE FOREST - Agenda Item No. 10

The City Council received a presentation from Orange County Fire Authority (OCFA) Division Chief Jeff Adams on recent changes to the deployment model for OCFA's emergency response units. The purpose of these changes is to realize greater operational efficiencies related to emergency incidents in Lake Forest. Thus, OCFA converted Engine 54, located in Foothill Ranch, from a 3-person Paramedic unit to a 4-person Paramedic Engine. OCFA believes these changes will provide a number of benefits, including greater service delivery, enhanced firefighter safety, and improved Advanced Life Support response times.

PROCLAMATION DESIGNATING THE MONTH OF APRIL 2016 AS "DMV DONATE LIFE CALIFORNIA MONTH" - Agenda Item No. 4

Over 123,000 individuals nationwide and more than 22,000 in California are currently on the national organ transplant waiting list for a kidney, liver, pancreas, intestine, heart, or lung. With demand far exceeding supply, a critical shortage of organs and tissues persists. Local governments are urged to encourage residents to become donors, support the collaborative efforts of organ, tissue, and eye agencies, and draw attention to the importance of being an organ and tissue donor. The City Council is pleased to support this worthwhile cause and designated April 2016 as DMV Donate Life California Month.

SENIOR MOBILITY PROGRAM SERVICE PLAN AND GUIDELINES - Agenda Item No. 14

Lake Forest's Senior Mobility Program is a key component of the services offered to Lake Forest seniors. The City uses funding provided by the Orange County Transportation Authority's Measure M2 to offer seniors 60 years and older transportation services for

medical and social/recreational visits in Lake Forest and Orange County. For a nominal fee, seniors may ride on the Age Well Senior Services bus or in a taxi. To continue its collaboration with OCTA, the City Council approved revised guidelines and related agreements with OCTA to clarify use of Measure M2 funds.

ANIMAL CONTROL SERVICES - Agenda Item No. 15

Since the beginning of the fiscal year, the City Council has held several discussions regarding the provision of animal control services. After considering sites for construction of a Lake Forest Animal Shelter, the Council voted on December 1, 2015 to remain with Orange County Animal Care (OCAC) and participate in the planned new construction of the OCAC Animal Care Center. At the April 19, 2016 Council meeting, the City Council received a presentation on the timeline of the new shelter's construction, heard a presentation from the Chief Veterinarian and Director of Shelter Operations at OCAC, and considered an alternative animal services model. After accepting public testimony and deliberating the various alternatives, the City Council voted to remain with OCAC and participate in the construction of the new OCAC Shelter.
