Adopt a Resolution entitled A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF LAKE FOREST OBJECTING TO THE PUBLIC SALE OF CERTAIN TAX-DEFAULTED PROPERTY LOCATED WITHIN THE EL TORO REDEVELOPMENT PROJECT AREA, OFFERING TO PURCHASE SAID PROPERTY AND FINDING THAT SAID PROPERTY WILL BE USED FOR A PUBLIC PURPOSE.
