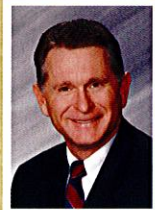

This past year we enhanced our business attraction efforts with the Lake Forest Economic Development video that features Lake Forest companies sharing why

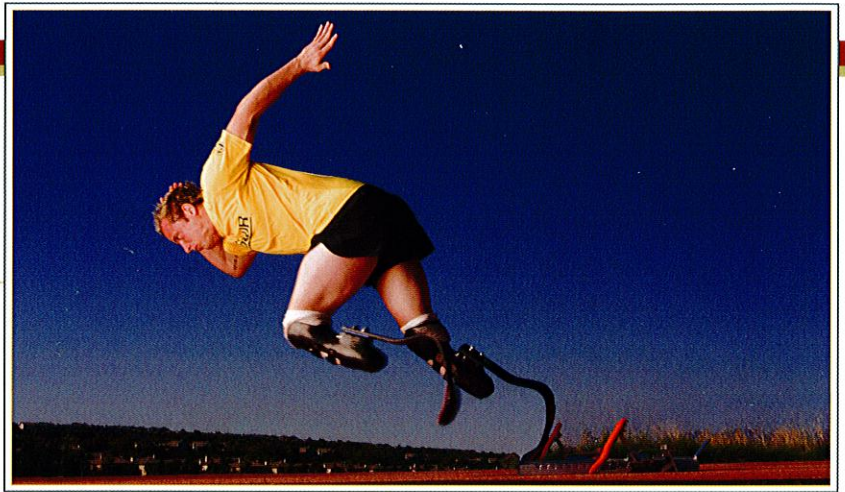

The company is expanding and relocating its Össur Americas headquarters to a second Lake Forest location at 27051 Towne Center. It will combine its Aliso Viejo and Camarillo offices to a 38,613-square-foot building, allowing 170 employees in sales, marketing, customer service, finance, and human resources to work cohesively under one roof. It also will maintain R&D and manufacturing operations at the original Lake Forest facility. Össur selected Lake Forest for its headquarters after extensive research, citing its positive experience with the City, a strong labor pool, and the locational benefits for attracting new employees as key factors. "Lake Forest offers our employees everything they need, such as a variety of restaurants and materials suppliers," said Mary Nash, Director of Marketing Communications. "Many of our employees live in the local area, so it is convenient for them."

Össur first came to Lake Forest in 2006 when it acquired Innovation Sports, a Lake Forest tenant since 1983. The acquisition of Innovation Sports is part of Össur's strategy to grow and advance its technological applications. # Business Tips: Reducing Occupancy Costs

## Tips for Office Space Tenants

While the recession has had a negative effect on most businesses, the soft demand for commercial real estate space has presented an opportunity for tenants to reduce occupancy costs. Tenants may be able to negotiate better leases if any of the following apply:

- 1) A lease expiring in the next two years
- 2) Have too much space
- 3) Signed a lease between 2005 and early 2008, which means that you are likely paying an "over-market" rate
- 4) Are in a building where the landlord has failed to provide adequate services or maintenance

We recommend maintaining an open dialogue with your landlord to address any occupancy issues. Along with great communication, here are a few cost-saving ideas:

### Renegotiate Your Lease

Most landlords are facing serious vacancies and recognize that the Orange County office space market is not going to improve for at least the next two years. Many landlords will "trade" a reduction in your current rent or a decrease in your current square footage in exchange for your commitment to extend your lease.

### Consider New Space

While it is expensive and disruptive to move, relocation today is a reality for tenants because of concessions other landlords may be willing to offer. We suggest you work with your real estate advisor

to become familiar with all the available properties for sale or lease in Lake Forest and to identify the most cost effective solution for your business. ### Sublease Your Excess Space

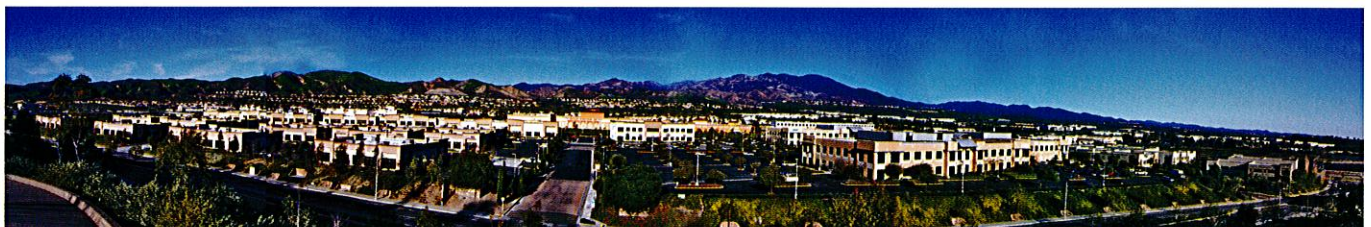
While the soft market conditions may make finding a subtenant difficult, subleasing excess space can reduce your total space costs, even if you offer a "below-market" rate in order to attract prospective tenants. Prepare to be flexible on the length of sublease term and on the financial strength of the subtenant. As always, confirm that your lease allows you to sublease excess space.

### Review Operating Expense and Common Area Charges

Landlords sometimes inadvertently overcharge for operating costs and other building maintenance items. Check your lease to see what expenses may be "passed through" to tenants. If you see an unusually large or questionable charge, you can retain your accountant or specialized "lease audit" firm to review the charges.

Ultimately, if your commercial lease situation is anything but perfect, we suggest you meet with your broker or real estate advisor to discuss ways in which you can use the economy's weakness to improve your company's space and profitability.

## Project Updates:

### Go Local: Connecting with Metrolink

A study is underway for a potential commuter shuttle that would transport Metrolink riders arriving at the Irvine station to northern Lake Forest business parks. In fall 2009, the City began Step Two of the comprehensive service planning process for the commuter shuttle program. This step will prepare the proposals to compete for Renewed Measure M funds as part of Step Three – the project implementation phase. Detailed service planning will include an analysis of passenger demands and needs, route segment performance, system performance, impact to existing fixed route service, ADA compliance, resource requirements, and financial parameters. Step Two will take one year to complete.

### Alton/Parkway Extension:

#### A Smoother Connection for Lake Forest

Completing the Alton Parkway gap closure is a major goal of the City and community. The project will be undertaken in two segments.

The County of Orange is the lead agency for the first segment between Irvine Boulevard and Commercentre Drive. Construction plans are complete, and the County recently awarded a construction contract. Pending approval of required regulatory permits, including the

California Department of Fish and Game, the County hopes to begin construction soon. Construction is expected to last twelve months.

The remaining portion of the gap closure, from Commercentre Drive to Town Centre Drive, is in the City limits. The completion of this segment is affected by the development of the surrounding land, which is owned by Shea Baker Ranch Associates (SBRA). The City is working cooperatively with SBRA to expedite the completion of this segment. The City Council recently awarded a design contract to begin construction plans. The City's goal is to complete the plans in time to allow for concurrent or a seamless continuation of construction once the County completes its segment.

## Broker Corner: Hard Decisions Made Easier- Opportunity in Lake Forest

This winter marks an end to a business environment unlike any we have seen in generations. The Orange County commercial real estate market continues to experience sharp adjustments with falling lease rates and property values, increasing vacancy, and lack of demand.

While fewer companies relocated or expanded and many downsized or renewed, some positive signs are surfacing. Many brokers feel that the maligned office market may finally be reaching bottom, and the industrial market has shown signs of life, posting slightly higher gross activity figures than that of last quarter. These times can offer opportunity for those who are prepared and well-informed. If captured, the declining market can offer historic savings for tenants and buyers in 2010.

A core of local corporations capitalized on economic incentives: I-Flow Corporation, Me & My Big Ideas, BH North America, and TMS renewed their leases in Lake Forest this year, absorbing nearly 220,000 square feet between them. The City of Lake Forest remained the right choice for their business with attractive rents, established business and residential communities, ideal employee base, and business-friendly regulations.

At the end of the third quarter, the City's combined vacancy rate for Industrial property (Manufacturing/Warehouse/R&D) was fairly low at 8.2% (compared to 14.6% vacancy in the Irvine Spectrum). Lake Forest's Industrial and R&D market remained reasonably healthy, with a vacancy rate of only 1.1%.

A few new tenants relocated to Lake Forest. Notable tenants were Aten Technology, which relocated from two facilities in the Irvine Spectrum to 40,000 square feet on Da Vinci, and Segue Corporation, which consolidated three Rancho Santa Margarita facilities into 32,000 square feet on Descartes in Foothill Ranch. Competitive economics, along with the high image, corporate neighbors, and strategic geographic location, made the site selection an easy decision for these businesses.

These case studies illustrate the opportunity that exists in this "down" market and how competitive the City of Lake Forest continues to be. Corporations can make assured and informed real estate decisions with expert advice and attention that characterize our team and the City of Lake Forest. Now is the time to plan for 2010 to ensure that the future is met with confidence, lower occupancy costs, and improved operational efficiencies.
