Hi David,

As requested, attached is a proposal to complete the CEQA documentation for the Jeronimo Road Widening Project. Eunice and I think a Categorical Exemption is still a possibility. However, we are aware there are trees

to be removed and excavation, so we decided to conduct biological and cultural investigations to determine if there could be impacts. If it is determined there would not be significant impacts to cultural or biological resources and there are not hazardous material issues in the project area, we can use a Categorical Exemption. If it is determined there could be impacts, we will proceed with a Mitigated Negative Declaration. Therefore, our approach includes two prices.

We have also included a scope and price for an optional task to address AB 52 Tribal Consultation. It is not included in the overall price for the project. If the City would prefer the support, we can add it to the overall cost.

Lisa,

I have a job for you that the City of Lake Forest is requesting a proposal on. We have been working with the City on the Jeronimo Widening project since end of 2019 which includes a widening component (see attached for plans). The City had indicated that environmental would be handled on the City's end but as we head in to the final stretch of the acquisitions (this project is now headed towards an eminent domain), it appears that environmental proceedings have not begun. Could you take a look and let me know what level of environmental review would be needed?

The proposed improvements are relatively minor from the widening and acquisition side (other than the need to pursue eminent domain) and do not add a lane of traffic or capacity to the street (purpose is to better align the lanes through the intersection and add a second left turn lane to reduce cuing/traffic at intersection). We do have two utility relocations of which one of them is a southern California gas vault that is being relocated and upgraded to current standards. The other relocation is a vent for a water line which is relocated in kind.

Can you take a look and then give me a call to discuss? I cant imagine this is a CE but hoping we are at a MND status and can knock out for the City. I'll be adding your scope to an add service for the Eminent Domain once we get those fees as well.
