### Hi Douglas,

Yes having no Plans for this project is a problem. Plans are required to verify the r/w statements contained in the right of way certification. It appears that there are manhole adjustments involved in this project, unless those are not being done as a part of this slurry seal project. I refer you to Article 5 page 59 of the Specs it references plans, and on Page 116 (see attached)? There is also no bid items listed in the specifications for the contractor to bid on? How does the contractor know what to bid on if there are no plans for him to look at as to where these manholes are located. You also have ADA work being done and sometimes and it is a rarity, but there could be utilities located under the ADA ramps therefore plans are needed to identify for the contractor if in fact there could be any utilities. Most slurry seal projects will not involve manhole cover adjustments or ADA work because there will not be any disturbance to the road, but in this case according to the Engineers estimate there is a lot more work involved besides slurry sealing the two streets? Unless this information is a mistake. The asphalt repair locations identified in the specs are only showing the cracks that need

repairing, there is no markings as to where the manholes are that will be adjusted, hence needing plans for this project. Also on those asphalt repair locations I can't tell where the city right of way is and that also needs to be indicated on the plans to verify what the city is certifying that all work is within the Cities right of way. This can't be verified by those repair locations. In order to certify this project, I refer you to the LAPM Chapters 13 & 14 as well as the Caltrans Right of Way Policies & Procedures Manual Chapter 17 for requirements, along with all of the guidance I submitted to you on 4-6-23.

If you would like to discuss further please let me know. At this time the Right of Way Certification package is incomplete and I can't review at this time, please resubmit once the city has all the required backup documentation to support the right of way cert.
