State Mandated Posting. DO NOT REMOVE!

Pursuant to Government Code Section 54970, the Maddy Act, on or before December 31st of each year, the City Clerk posts a list of all ongoing boards, commissions, and committees, which are appointed by the City Council. The City of Lake Forest encourages residents to apply for positions on City Commissions. Qualifications unless otherwise specifically provided by law or ordinance of the City Council, are as follows: all members of boards and commissions of the City shall, at all times during their incumbencies be bona fide residents and registered voters of the City; no member of any board or commission shall be a City employee or person under an employment contract subject to the jurisdiction of the City Council; nor shall any person be a member of more than one (1) board or commission at any one time.
