## Public Hearing(s):

- ▶ **Item 9: Public Hearing No. 4 – Transition to District-Based Elections**
- ▶ City Council may conduct the fourth of five Public Hearings related to the creation of geographic voting districts and the drawing of district boundaries and may select a final district boundary map and determine the sequence of district-based elections, to be adopted by Ordinance following the fifth Public Hearing.

## ▶ Discussion Items

- ▶ **Item 10: Civic Center Project Update**
  - ▶ City Council may receive an update on the Civic Center Project, and consider two related actions:
    - A. Construction Contract Award for the Street Improvements and Utilities for  
Civic Center Drive**

City Council may award a contract in the amount of \$3.4 million to Boudreau Pipeline Corporation of Corona for street improvements on Civic Center Drive.
    - B. Award of Lake Forest Civic Center Owner’s Representative Services Contract**

City Council may award a contract in the amount of \$375,170 to Red Brick Consulting of Dana Point for owner’s representative services related to the Lake Forest Civic Center Project.
- ▶ **Item 11: Updated Discussion Regarding Wireless Deployment**
  - ▶ City Council may discuss a request to locate small cell facilities in the public right-of-way from Verizon Wireless.

## ▶ Discussion Items

- ▶ **Item 16: Discussion of the City's Existing Regulations for Freeway-Oriented Signage**
  - ▶ City Council may discuss the City's LFMC permits in connection with on-site freeway-oriented signage on commercial property subject to Planning Commission approval of Planned Sign Program (PSP). The Code authorizes the Planning Commission to grant deviations from the standards in the Code, on a case by case, in order to address site-specific constraints and to encourage creativity. City Council has several options regarding freeway-oriented signage: The Council may maintain the current LFMC provisions for case-by-case review of signs, direct staff to prepare specific amendments to the Code, or direct staff to explore alternative approaches to freeway-oriented sign regulation.
- ▶ **Item 17: Recreation Software Transaction Fees**
  - ▶ City Council may discuss whether to authorize continuation of the current practice of absorbing the costs of transaction fees associated with the recreation registration software in lieu of passing the fees on to program registrants and may direct staff to update the City Council on software transaction fees during the annual budget process.
