I understand that the city is proposing a new traffic light just above the Glenn Ranch Road intersection on Saddleback Ranch. I'm writing you today to request that you reconsider this proposal. The Glenn Ranch Road (GR) intersection has a 2-lane left turn lane, and through much of the day, there is a lot of traffic that goes up Saddleback Ranch (SR). Because of the steep incline, traffic does not move very quickly up that road, and adding an extra traffic light on SR, just a few hundred feet above GR, will cause serious traffic issues. If this light is approved, many cars will get stuck turning left from GR to SR for 1-2 extra light sequences

I recommend Baldwin instead put traffic lights on Glenn Ranch Road for the new community. It may require them to reassess how they plan to build the homes, but if this is not done, adding that light on Saddleback Ranch will cause the Trabuco Canyon residents a lot of grief and add too much traffic to an already congested intersection.

Mr Santos:

As a resident of the Portola Hills community and a long-time resident and business owner in Orange County, I am writing to share my concerns regarding the Portola Center development project.

It is clear to me that the developer is trying to present their plans in the best possible light, which one would expect, but doing things like running a traffic study on a holiday weekend when school is not in session strikes me as a deliberately deceptive tactic designed to minimize the perceived impact on the already terrible traffic conditions in the area. I would invite you (attempt) to drive on Saddleback Ranch Road past Portola Hills Elementary at 8am on a school day, and experience it for yourself, but sadly that will not be possible until September for obvious reasons, so I will attempt to describe it for you. Parked cars line both sides of the two-lane street for a thousand feet or more on either side of the school, and the existing light is completely clogged with cars attempting to turn into the tiny school parking lot. As a result, you will sit immobile for several minutes while the lights change from red to green and back again several times. If you are willing to make an illegal lane change and drive in the lane opposing traffic, you stand a chance of getting around the congestion, provided you can return to your lane before reaching the light and being stopped by the crossing guards or hit by oncoming traffic. Adding new traffic lights in close proximity to existing lights is only going to exacerbate the gridlock during peak traffic times.

Directing additional traffic onto this street without providing alternative (or preferably primary) routes onto Glenn Ranch is sheer folly.

Additionally, the proposed design for the retaining walls is likely to be a problematic eyesore. The area of Portola Hills is subject to subsidence, and significant maintenance will be required to keep those walls intact, and prevent expensive damage to the homes they propose to build. However, past experience with Baldwin has shown us that should this become a financial burden to them, they will not hesitate to declare bankruptcy and abandon the development, forcing those costs onto the homeowners and the city.

The developer is also clearly interested in dramatically increasing the density of the area, something that will degrade the property values of the existing residents, and contribute to the burgeoning crime problems that are developing in the area.

I therefore urge you to recommend to the city council to disapprove the plans as submitted, and require the developer to redesign their proposal to address these concerns, shared by hundreds of residents of the Portola Hills neighborhoods. The plans need to better accommodate the traffic increase, as well as to reduce the density of the development to match the existing developments in the area.

I have lived in Portola Hills for over 16 years. We love living in this area, but have felt that the representation to our area has grown over the years to be secondary or an afterthought to those in government that represent us. Up to this point, the worst thing that occurred was the line adjustment for determining which Jr. high and High school our children would go to. This was very frustrating when we bought our house, as we had bought here so our children would go to RSM Jr High and Trabuco HS, but this was taken away 5 years after we moved here. I'm telling you this just to give you some context of our frustrations. Please know this is **NOT** aimed specifically at you, just a general disappointment of not feeling heard and represented.

I fully appreciate and understand the rights of landowners to develop the parcels they own, and have in fact work with developers...I am in commercial RE Finance. I also understand the need to accommodate existing homeowners in proposing a new development, and this is where I feel Baldwin has failed. I was made aware that not only is there a proposed entrance to the new community on Saddleback Ranch Road only a few hundred feet uphill from the Glenn Ranch intersection, but that it is to be controlled by a traffic signal. There is already significant traffic/congestion during commuting hours not only from those living here, but also those on El Toro road cutting through Ridgeline road as a shortcut, and those dropping off their children at Portola Hills Elementary.

To have two signal controlled intersections within such close proximity to each other, with new residents turning both ways, will inevitably result in an accident and people getting hurt, or worse. One cannot expect to have that much traffic added on a steep hill to a small residential road, add a traffic signal that is less than the length of a football field away to an existing signal light, and not expect to have traffic issues and increased odds of accidents. I would expect to see cars racing through to "beat the next light" creating a more dangerous situation than if there were no signal at all. If there were no other solution, perhaps we would have to live with it. But there is another solution. The new communities would be easily accessed from Glenn Ranch Road without impacting the value of the new homes whatsoever.

In short, I ask that you consider, and to the greatest extent possible minimize, the traffic impact to existing residents...and consider the safety of all those living in the community.

Dear Mr. Santos and the City of Lake Forest,

My wife and I have lived in Portola Hills for nearly twenty-two years. When we moved into our Baldwin house above the school on Dorado Drive – the school had not been built yet. Glenn Ranch did not exist, and for that matter neither did Portola Parkway. Saddleback Ranch Road was a relatively quiet street that ended at Millwood. After Millwood, it turned into a dirt track that disappeared into scrub at the base of the hill. Everyone who lived in Portola Hills used the Ridgeline entrances as their main way in or out of our community – we had to. And it worked quite well because traffic dispersed in an efficient, safe, and effective way based on the original traffic flow patterns dictated by using these entrances.

That changed completely when Portola Pkwy, Glenn Ranch, and Saddleback Ranch were all connected. Overnight Saddleback became the main entrance to Portola Hills and the vast majority of residents use it as their daily way in and out of our community. Very few residents use the Ridgeline entrances anymore. Saddleback Ranch has many, many problems. First it has a long steep decline from the top of the hill starting at Concourse Park. It is incredibly easy to pick up speed as one heads downhill (and most people do pick up speed). Down the road at the Malabar St. intersection there is pretty much a blind curve when one tries to make a left turn out on Saddleback. Add the fact that traffic is racing at nearly 50 miles per hour in both directions between Shady Ridge and Millwood. The Pendleton Rd. intersection (directly above and adjacent to the school) has become the site of many accidents because Pendleton is used as a shortcut for drivers who live in the original central and eastern Portola Hills neighborhoods - even the Fire Department uses this shortcut to get to Saddleback Ranch. The problem here is one of safety as both the uphill and downhill speeds drivers use on Saddleback make it dangerous to turn left or right from Pendleton.

There is one traffic signal on Saddleback Ranch, which is located at Fawn Ridge in front of the school. This is one of the only true traffic-calming devices we have on Saddleback and most of the time it's a green light for both the uphill and downhill traffic flows. The new speed monitoring sign is nice, but we don't consider it an effective traffic-calming device.

Portola Hills Elementary School was poorly sited by being located on Saddleback versus in another part of the development. The street lane design at the school and the placement of the parking lot entrance is tragically flawed. For nine months of the year while school is in session, (as well as whenever there is a special after-school function), we have significant daily traffic congestion and public safety problems around the time school starts and ends.

We know these issues are "outside the scope of the project" which is a phrase very carefully used by both the representatives of the Baldwins and the City of Lake Forest whenever issues about traffic in our existing community are brought up. It's worth noting, the Baldwins were the master developer of Portola Hills – they designed our existing problems. So try to understand our lack of faith in the abilities of the same developer. The point we want to stress is if you don't understand what's happening at the top of the hill, you will never understand why this community is so against what the developer is planning to do traffic wise at the base of the hill.

Common sense and logic suggest no matter what the Baldwin/City of Lake Forest traffic study data shows (hopefully we will be allowed to see it and analyze it for ourselves), when you build 930 homes thereby increasing the total number of households in Portola Hills by a third - you are going to increase traffic and increase congestion especially at the base of the hill. Some of that traffic and congestion is going to go up the hill on Saddleback Ranch - now that may be "outside the scope of the project" but it is going to happen and

our existing community is going to be impacted. Apparently, the City and the Baldwins will continue to insist they have no responsibility to mitigate our community's increasing "existing problems." So be it - for the time being. But know that we as a community are finding our voice – and we will want to talk very soon with the City in depth, about true solutions for our "existing problems" on Saddleback Ranch between Millwood and Concourse Park.

So lets talk about the section of Saddleback Ranch that is "within the scope of the project". At one of the very first City of Lake Forest Opportunities Study meetings back in the early 2000s, we met and talked with a Mr. Kilkenny, executive vice president of the Otay Ranch Co., a shell company owned and run by the Baldwin Brothers. In those early meetings, the Otay Ranch Company was introduced to the public as the developer. That night we requested the tentative plans for the lower parcels of undeveloped land in Portola Hills. Mr. Kilkenny kindly sent us early tentative tract plans showing the entrances of new development on Saddleback Ranch. Those very first plans are why my wife and I, along with many others are writing to you. Because those very first plans that we saw almost 10 years ago are identical regarding entrances on Saddleback Ranch to the current set of tentative plans. The Baldwins have always wanted these two entrances 450 feet up from our busiest intersection, which is Glenn Ranch and Saddleback. They want them there because they are the cheapest and most efficient way to utilize their land to create the maximum amount of lots they can build on. Basically – they move less dirt if they get these two entrances. And just for record, the Baldwins are going to be moving massive amounts of dirt all over these three parcels, so please do don't insult us by somehow saying this is a good environmental solution. It's definitely not about mitigating our traffic problems as was mentioned by the Baldwins at the last community meeting, which was received with laughter on our part. And it's certainly not about helping the quality of life for the original residents of Portola Hills. In the end it's all about them moving dirt where they want to move it and making money.

If the City allows the Baldwins to build these entrances on Saddleback, they create a new 4-way intersection, which warrants traffic signals. This new intersection would create traffic congestion where it never existed before, thus adversely impacting the traffic flow for the existing 2,181 original households in Portola Hills. All of this to serve 280 new homes in Portola Center. The bottom of the hill portion of Saddleback Ranch in the Portola Center region is at carrying capacity for the morning and afternoon rush hours. This area is like the bottom tip of a funnel. All traffic up or down Portola Hills leads through this area. And the Baldwins traffic mitigating solution to all this is to help clog the tip of the funnel with a new signalized 4-way intersection leading to two gated developments. Thanks for being part of our community Portola Center.

As we previously stated, the Saddleback Ranch/Glenn Ranch intersection is the busiest in the Portola Hills community – we know this because we live here. It will become even busier because while it is currently a 3-way intersection, it will become an active 4-way intersection and will function as one of the entrances to the southern parcel of Portola Center. Currently, this parcel has 2 planned entrances for over 626 residences, a 5-acre sports park, and commercial interests. This means we will see car traffic, and pedestrian traffic there in ways and in numbers we have never seen before.

So how can these entrances on Saddleback Ranch be removed? Our suggestion for the NE Parcel - 2 entrances on Glenn Ranch. There is more than half a mile of frontage along Glenn Ranch for the NE parcel from Saddleback Ranch to El Toro and this roadway is extra wide and less utilized.

Our suggestion for the NW parcel is that an entrance be built on the border of the Whiting Ranch boundary line in the style similar in design to the entrances for the Painted Trails neighborhood on El Toro Rd only a mile away. This again would remove any need for an entrance for the NE parcel on Saddleback Ranch.

We would like to point out that at one time the Saddleback entrance for the NE Parcel was removed and put on Glenn Ranch. This tentative plan was still valid less than a year ago. We would like to know what happened to that entrance, and why the Saddleback entrance for the NE Parcel is back in the current tentative plan.

In closing, we found something today on the City website about the Portola Center that we want you to read and convey our hope that city officials carefully think about and remember. These are the City of Lake Forest words not ours.

"As the Project moves from the programmatic (big picture) phase to the project (details) phase, the City's role is to ensure the applicant delivers the best possible project, and the community receives the greatest public good." Sincerely,

Dear Mr. Santos,

Although I am not happy with the building which will be taking place in our Portola Hills community, I understand the land is owned by the Baldwin Company and they have the right to build on it ... even if they are taking away the beautiful an charm of the community. (Of course this is another story.)

I am writing today to express my deep concerns over the proposed 4-way traffic signal on Saddleback Ranch Road. A different way to exit these new communities is what is in order, not a traffic signal!

I need to stress that the traffic in our area is horrible and quite scary to say the least. In last night's commute home, there was a traffic issue that made it take 20 minutes to get from Bake & Portola Parkway to my home on Chimney Rock Circle. While this is the worst I have ever seen, it is <u>not</u> uncommon for it to take 6-8 minutes to drive from Portola Parkway & Glenn Ranch Road to my home. The traffic starts to build up at the left turn at Portola Parkway going onto Glenn Ranch Road. Many times it takes two light cycles to get through the light. Then, the lights on Glenn Ranch are not in sync whatsoever, so by the time you hit the first red light on Ellipse and then the second red light on Definition, people are very irritated and I find that they race up the hill ... only to stop again at another red light with a left turn. Once they make that turn (which is a two lane turn lane), everyone is piled up against each other trying to merge into the left lane to go straight. Millwood is only a short distance up the hill, and that intersection has had quite its share of accidents and close calls ... a very scary intersection.

If there is a 4-way light prior to Milwood, I am afraid there are going to be multiple rearing-ending accidents resulting from the amount of cars coming from the left turn lane on Glenn Ranch. A light will cause a HUGE back up in the turn lane and will impact the intersection (Glenn Ranch & Saddleback Ranch) because I feel it will be blocked creating more rage.

Our area is already a very dangerous traffic area for our children at Portola Hills Elementary (PHE). I believe the City of Lake Forest has spoken with PHE Principal, Mr. Rawlins about the school's traffic issue ... just up the street from the proposed signal. However, I understand you have given him no assistance on solutions to that traffic nightmare. I fear for our children and the poor crossing guards EVERY school day as there have been so many close calls.

Adding a 4-way signal between Glenn Ranch and Millwood will create more traffic problems for an area that already has issues, with no resolution. It is not the answer to the traffic problem. With so many more cars and a limited way to enter and exit these new communities, it is **TERRIBLE** and **SHAMEFUL** planning. What you really need is different exit/entrance strategies not a 4-way signal. (I hope we never experience another fire like we did a few years ago, as you will truly have a nightmare on your hands.)

Traffic flow is a huge safety issue that has not been clearly communicated to our community. The City of Lake Forest needs to address these concerns with transparency and the reality of a full traffic study done during the school year, not during vacation times.

The installation of a new 4-way intersection and traffic signals on Saddleback Ranch Rd. with gated communities is the dumbest thing I have ever heard, especially for only 280 new homes. There are 2,181 homes in the original Portola Hills community. That installation will result in massive traffic jams at all hours of the day and night. I vehemently oppose dumping 280 cars on to Saddleback Ranch Rd. That street is crowded enough as it is.

Where is the traffic study? Probably taken at night or on a holiday weekend and using the other ingress and egress instead of during the height of traffic volumes.

Bring out the traffic study so all Portola Hills residents can review and comment.

There is 600' of frontage on Glenn Ranch from Saddleback Ranch intersection (going toward Portola Pkwy) to the Whiting Park Boundary. There is the ability for Baldwin to put a gated entrance along Glenn Ranch for the NW parcel (80 homes) similar in design to the entrances to Painted Trails neighborhood on El Toro Rd. Baldwin would have to move some dirt and build on less lots. That would dump the traffic on to Glenn Ranch instead of Saddleback Ranch. There is 2,900' of frontage along the SW parcel on Glenn Ranch between El Toro and Saddleback Ranch – that is more than ½ mile. There is plenty of room to put both entrances along Glenn Ranch, rather than using Saddleback Ranch. Again Baldwin would have to move some dirt and build on fewer lots.

Mr. Santos,

I have recently learned of the intentions of placing a 4-way traffic signal on Saddleback Ranch Rd. When I saw the proposed location, I was surprised. To me it makes no sense, the proposed intersection is only roughly 450 feet above the existing Glenn Ranch Rd/Saddleback Ranch Rd intersection. This would create traffic congestion where it never existed before. I am a resident of Portola Hills, I live off of Saddleback Ranch, and I do not see how it is possible to place such an intersection in the location that is being contemplated, without causing congestion problems in that area.

If such an intersection is placed, then the patrons making a turn off of Glenn Ranch Rd onto Saddleback Ranch Rd would encounter another street light which will be frequently turning red since it will be the entrance to a residential area.

The current traffic turning on Saddleback Ranch Rd from Glenn Ranch Rd is already heavy, once such an intersection is placed, it would make matters worse.

The following scenario can be expected: Both Glenn Ranch turning lanes are full, as they usually are, once the light turns green the cars turn only to come to a stop a mere in 450 feet, those 450 feet (from intersection of Glenn Ranch/Saddleback Ranch to the proposed 4-way

intersection) is not enough to accommodate all of the cars that have filled the Glenn Ranch turning lanes, therefore congesting the 450 foot segment and leaving a majority of the cars in the Glenn Ranch turn lanes waiting for the next light cycle.

With the above being said, even at times when such a scenario is not present, the 4-way intersection will still disrupt the current traffic conditions in the area of concern.

There is plenty of room to place such an entrance on Glenn Ranch Rd, adjacent to the Whiting Ranch Park.

In order for such a intersection to be placed, an adequate traffic study needs to be conducted that would yield positive results for the new and especially the existing residents of this community, and I do not see how that would be possible with this proposed location.

It is important that the residents of Portola Hills are fully aware and have access to all of the traffic data for this development.

Adding the 4-wayintersection 450 feet above the existing intersection of Glenn Ranch/Saddleback Ranch would add more traffic in that area an make the commute unpleasant for patrons commuting from work and other places.

We would like to take this opportunity to express our concern regarding the 4 way intersection with traffic signals which has been proposed for our neighborhood. We are concerned about the significant traffic congestion and the impact on the flow of traffic this signal will cause on Saddleback Ranch Road. There is already a bottleneck of cars during the current rush hour.

None of the board members live in Portola Hills so they are not familiar with the traffic patterns in our neighborhood. All students above sixth grade attend school outside the neighborhood so families are making multiple trips to schools and for after school activities. This is on top of all of the people who commute back and forth to work. Most afternoons the left turn queues from Portola Parkway onto Glenn Ranch are full. My children never had a park to play in either, that park we were promised was never built until a few years ago.

I sincerely hope the City of Lake Forest will actually do what is right for our community and will monitor "Baldwin" and take any steps necessary to address this crucial proposed change to our community.

My next concern is with the area currently being targeted for a new intersection. It is my understanding that Baldwin plans on building a 4 way intersection on Saddleback Parkway between Millwood and Glen Ranch Road. If this is done there will be 2 intersections within a span of less than 450 feet. This particular strip of road is not suited for two intersections put so closely together. It is a main entrance out of the development and there is already a significant amount of traffic traveling at high speeds out of this area.
