CR-05 - Goals and Outcomes

Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

The City of Lake Forest 2020-2024 Consolidated Plan (ConPlan) established objectives for the City's Community Development Block Grant (CDBG) program in order to create a viable community by providing decent housing, a suitable living environment, and economic opportunities, principally for persons of low- and moderate-income. The objectives identified in the ConPlan included the following:

- 1. Rehabilitate the City's existing single-family housing stock, including mobile homes,
- 2. Conserve the existing supply of affordable housing,
- 3. Provide supportive housing and services for the homeless and those at risk of becoming homeless,
- 4. Provide needed community services and infrastructure improvements benefitting low- and moderate-income persons and those with special needs, and
- 5. Focus on expanding economic opportunities for low- and moderate-income residents.

During Fiscal Year 2020-2021 (FY 20-21), the first year of the five-year ConPlan cycle, the City carried out a variety of activities to address ConPlan objectives, including the following:

- Assisted with the rehabilitation of nine housing units owned by low- and moderate-income households
- Funded a variety of safety net public service grant programs to prevent homelessness and assist lower-income households over 1,250 Lake Forest residents were assisted
- Two capital projects were undertaken during the reporting period: El Toro Park Phase 1
 Improvements and the installation of Accessible Pedestrian Signals (APS) at two intersections –
 the City encountered delays with both projects due to the COVID-19 pandemic

During the FY 20-21 reporting period, the City also implemented activities funded with CDBG-Coronavirus (CDBG-CV) funds. The City received \$862,153 in two rounds of CDBG-CV funding. Round 1 funds were used to fund three nonprofit agencies that provided rent and utility, food, and case management assistance to Lake Forest households impacted by the COVID-19 pandemic. A total of 547 Lake Forest residents were assisted during the reporting period. Funds were also allocated to help small businesses impacted by the COVID-19 pandemic. In response to the severe and immediate threat of COVID-19 to the health or welfare of customers and employees, the use of grant funds was limited to purchase personal protective equipment (PPE) or to pay for critical utilities such as water, electricity, and gas. Eighty businesses were assisted during the reporting period. Additional CDBG and CDBG-CV funds were also allocated to support a second business grant program; however, implementation of this program has been delayed due to the unexpected second round of CDBG-CV funding.

In addition to these CDBG-funded activities, the Orange County Housing Authority (OCHA) assisted 192 Lake Forest renter households with a rental assistance voucher or certificate. OCHA is the local public housing authority that administers the HUD rental assistance program in Lake Forest. **Attachment 1** -

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

As summarized above, the City focused CDBG funds on addressing ConPlan priority needs during the reporting period. Consistent with the ConPlan, the City focused public service grant resources on safety net programs for lower-income households. In response to the COVID-19 pandemic, HUD waived the 15% public service cap, which allowed the City to "super-fund" public service grants — the City allocated approximately 38% of 2020 CDBG funds for public services. FY 20-21 reporting period accomplishments include the following:

- South County Outreach's food bank program allowed lower-income households to focus limited financial resources on maintaining housing, thus preventing homelessness.
- Family Assistance Ministries provided food, rent, and utility assistance to lower-income households at risk of eviction and utility service shut-off. Program participants also benefitted from case management services.
- Families Forward provided transitional housing and rapid rehousing, including supportive services to homeless families with children.
- Camino Health Center provided reduced-cost medical and pediatric dental care services for lower-income households, including the uninsured and the homeless.
- Age Well provided case management services to assess homebound seniors' health and living situation, thus helping seniors remain healthy and housed and avoid costly institutionalization in managed care facilities. Due to mandatory shut-down orders, services were offered via telephone well-checks.
- Alzheimer's Orange County provided reduced-cost daycare services for seniors with Alzheimer's, dementia, or disabilities. Due to mandatory shut-down orders, services were provided online or by telephone well-checks.
- Vocational Visions provided developmentally disabled adults with employment training, placement, and job coaching services to help program participants supplement their income and maintain independence. Due to mandatory shut-down orders, services were offered online.
- Fair Housing Council of Orange County provided fair housing outreach, education, and enforcement service for tenants and landlords. Due to the COVID-19 pandemic, services were offered online.

The City's housing rehabilitation program helped preserve and improve the City's existing stock of owner-occupied housing (including mobile homes) - nine homeowners received housing rehab assistance during the reporting period. Typical improvements include installing energy-efficient windows, heating/ac systems, plumbing, roofs, flooring, and exterior painting. The City's Neighborhood Pride Paint program was not funded during the reporting period to ensure CDBG resources were available to respond to local impacts of COVID-19. As indicated above, OCHA provided rental assistance to 192 Lake Forest renter households, including seniors, disabled, homeless, and veteran households.

To maximize CDBG resources to address COVID-19 issues in the community, the City did not fund public infrastructure or facility improvements in FY 20-21; however, two prior year projects were underway during the reporting period. Improvements at El Toro Park were delayed due to the reprogramming of a portion of project funds for COVID-19 relief, and supply chain challenges delayed the installation of APS pushbuttons. A summary of activities funded in FY 20-21 is provided in **Attachment 1 - Appendix 1**.

CDBG-CV funds were used to provide urgent need assistance to 80 Lake Forest businesses. Funding was limited to the purchase of PPE and the payment of in-arrears rent and utilities that helped businesses meet public health and safety requirements necessary to reopen. Funding was also provided to assist Lake Forest households experiencing the financial impacts of COVID-19 to pay back rent, utilities, or access food banks – 547 residents benefitted from these services. Narrative

According to the U.S. Census Bureau, most Lake Forest residents are racially White – 65.9% (2019 American Community Survey 5-Year Estimates). This same data source reports that 18.8% of City residents are Asian, and 21.9% of the City's population is Hispanic/Latino – these are City's most prominent minority populations.

Based on the data from Table 2, 76.2% of program participants are White; most of these individuals are reported to be ethnically Hispanic/Latino (52.0%). A closer examination of the accomplishment data from individual activities provides added insight. Among homeless and safety net programs such as housing, food, and medical services, most clients served are lower-income Hispanic/Latino households. This data indicates that these households may be economically unstable and therefore seek assistance in the hope of stabilizing their living situation. Table 2 indicates that residents accessing CDBG-CV funded services were also predominately White Hispanic/Latinos (58.5%).

Accomplishment data provided for CDBG and CDBG-funded activities also indicates that most program participants are extremely low-income Lake Forest residents (i.e., individuals with a household income equal to or less than 30% of the County median income). During the FY 20-21 reporting period, 82.2% of CDBG-funded program beneficiaries and 76.4% of CDBG-CV program beneficiaries are extremely low-income.

Narrative

According to the City's 2020-2021 Annual Action Plan, the City anticipated utilizing \$616,421 in CDBG program resources to address community needs during the reporting period. This amount is comprised of the City's 2020 CDBG Annual Allocation of \$513,771, plus \$72,650 in prior year funds and \$30,000 in anticipated program income from housing rehabilitation loan repayments. (The City received \$238,010.61 in program income during the reporting period.) As reported in Table 3, the City expended \$432,029 in CDBG funds during the FY 20-21 reporting period, including \$115,928 in program income.

During the reporting period, the City received \$302,281 in CDBG-CV Round 1 and \$559,872 in CDBG-CV Round 3 funds for a total of \$862,153 in CDBG-CV funds. (Round 2 funds were allocated to state governments). As indicated in Table 3, \$253,316 in CDBG-CV funds were utilized during the FY 20-21 reporting period.

IDIS Program Report PR26 (Attachment 1 - Appendix 2) provides a detailed summary of CDBG and CDBG-CV expenditure for the report period.

Narrative

The response to the COVID-19 pandemic, the City utilized approximately 97.0% of CDBG funds to address the needs of lower-income Lake Forest residents on a citywide basis. A small percentage was spent on El Toro Park, which is located in a CDBG Target Area. For reference, **Attachment 2** provides a map of the City's CDBG Target Areas. All CDBG-CV funds were spent on a citywide basis.

The City of Lake Forest made every effort to leverage CDBG funds to the greatest extent possible. Unlike prior years, no additional resources were used to leverage CDBG funds during the FY 20-21 reporting period.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

Despite the challenges of the COVID-19 pandemic, the City exceeded planned housing rehabilitation program goals for the FY 20-21 reporting period. The 2020-2021 Annual Action Plan established a one-year goal to rehabilitate eight owner-occupied housing units - program staff assisted with the rehabilitation of nine units. OCHA assisted fewer Lake Forest households with rental assistance than anticipated. The City expected OCHA would assist 200 households during the reporting period – 192 households were assisted. (Note: The number of households assisted by OCHA is based on several factors out of the City's control.)

Discuss how these outcomes will impact future annual action plans.

Even though program staff exceeded planned housing rehabilitation goals during the report period, the program may face future challenges. Low interest rates and other financing programs from private banks (e.g., reverse mortgage) offer homeowners alternate financing options to repair their homes. Furthermore, because mobile homeowners may be unable to obtain private financing to rehabilitate their homes, the City's rehabilitation programs present viable alternatives. Seven of the nine housing units rehabilitated during the FY 20-21 reporting period are mobile homes. The following factors are pertinent to this trend:

- Rehabilitation of mobile homes often requires specialized craftsmanship; therefore, few
 contractors specialize in rehabilitating mobile homes. Despite the staff's efforts to solicit
 qualified contractors for the program (including minority and women-owned businesses), the
 mobile home contractor pool is limited. At times, specialized contractors cannot take on more
 work; the COVID-19 pandemic exacerbated this issue.
- 2. Because it costs less to rehabilitate a mobile home coach than a single-family unit, the City spends less CDBG funds per unit. This situation can impact the City's ability to meet HUD's expenditure rate requirements for the CDBG program (i.e., an unspent grant balance of less than 1.5 times the City's current year grant spent 60 days before the end of the program year).

Approximately 5% of the City's housing stock are mobile homes; therefore, assistance for coach owners is likely to continue. To help ensure the City meets its CDBG expenditure rate requirements, the City will focus marketing efforts on single-family housing rehabilitation loans in the following year.

Narrative Information

Table 7 provides information regarding the households that received housing rehabilitation assistance during FY 20-21. OCHA reports 192 Lake Forest very low-income and extremely low-income renter households received rental assistance during the FY 20-21 reporting period. The City is not a recipient of HOME funds.

CR-25 - Homeless and Other Special Needs 91.220(d, e); 91.320(d, e); 91.520(c) Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

During the FY 20-21 reporting period, Lake Forest did not allocate CDBG funds for homeless outreach. Mercy House provided outreach and engagement services to chronic homeless with an Orange County Sheriff Homeless Liaison Officer's support - Mercy House was funded with non-HUD resources.

Addressing the emergency shelter and transitional housing needs of homeless persons

During the FY 20-21 reporting period, the City did not fund emergency shelter programs. Funding was allocated to Families Forward to provide interim/rapid rehousing housing. A total of six homeless families with children (21 individuals) were assisted with housing and support services during the FY 20-21 reporting period.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

The City's homeless strategy delineated in the ConPlan calls for providing safety net services that help prevent individuals and families from becoming homeless. To this end, during the FY 20-21 reporting period, CDBG funding was allocated to Family Assistance Ministries and South County Outreach to assist households at risk of becoming homeless. South County Outreach provided food and essential household items to 838 lower-income Lake Forest residents during the reporting period. Family Assistance Ministries provided rental and utility assistance that helped 11 Lake Forest residents facing eviction or utility service shut-off. They also offered food and case management services for 44 additional Lake Forest residents.

The City also allocated CDBG-CV funds to three agencies, which provided rent, utility, and food assistance to households impacted by the COVID-19 pandemic. Cumulatively, these agencies assisted 547 individuals during the reporting period.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals

and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

As recently as FY 15-16, the City utilized local funds (former redevelopment resources) to acquire residential properties to be used as permanent affordable housing. As reported in the 2015-16 CAPER, the City sold a four-unit apartment building to Families Forward. Families Forward operates these units as permanent, affordable housing for lower-income households. These units will remain affordable for lower-income households for a minimum of 55 years. The City did not undertake a similar activity during the FY 20-21 reporting period; however, OCHA reports 192 Lake Forest households were assisted with rental subsidies during the reporting period. This figure includes four disabled Lake Forest homeless households (benefitting from Continuum of Care Program Permanent Supportive Housing Certificates) and 16 homeless, disabled veteran households that benefitted from Veterans Affairs Supportive Housing (VASH) vouchers.

CR-30 - Public Housing 91.220(h); 91.320(j)

Actions taken to address the needs of public housing

The City of Lake Forest does not own or manage public housing.

CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

The 2020-2021 Annual Action Plan indicated that the City would address affordable housing barriers by providing resources to assist social service agencies that provide fair housing counseling and housing referral services for low- and moderate-income and special needs populations. During FY 20-21, the City provided funds to the Fair Housing Council of Orange County (FHCOC). Services provided by the Council included outreach, education, and fair housing enforcement. A total of 68 households were assisted during the reporting period addressing 218 issues and disputes related to rental agreements, notices, security deposits, unit habitability, and more. FHCOC reports one housing discrimination complaint was received from a Lake Forest resident during the year; however, the issue was resolved through counseling.

The Consolidated Plan and Action Plan also indicated barriers to affordable housing development would be addressed by considering ways to reduce development fees and expedite the entitlement review process. As previously outlined, the City has provided various subsidies to create new affordable housing opportunities for lower-income households; however, no affordable housing development was completed during FY 20-21.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

The City recognizes that special needs populations face challenges due to low income and their particular life situation. Special needs populations often require housing accommodations and supportive services. The City considers supportive services and housing for special needs populations as a high priority. During FY 20-21, the City funded several public service agencies that provide a social safety net to help at-risk households. The services provided include free or reduced-cost food, healthcare, and daycare services. CDBG funding was also utilized to assist adults with developmental disabilities in obtaining and maintaining jobs.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

The Residential Lead-Based Paint (LBP) Hazard Reduction Act of 1992 (Title X) changed the federal approach to addressing LBP by emphasizing preventing childhood lead poisoning through housing-based strategies. The City considers lead-based paint hazard reduction as an eligible activity in the City's housing rehabilitation programs.

All application packets for the City's housing rehabilitation programs include a notice to educate residents about the health dangers of lead and encourages children's screening for elevated blood-lead levels. Additionally, before federal funds are used for housing rehabilitation, all units are screened for

lead-based paint hazards. Housing units identified with lead-based paint are treated, so paint hazards are abated per federal requirements.

The use of lead-based paint has been prohibited since 1978. All housing units rehabilitated during FY 20-21 met an exemption allowed under HUD lead-based paint program regulations.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

According to the U.S. Census Bureau, approximately 6.9% of Lake Forest residents have incomes below poverty. Specifically, 7.2 % of City residents age 65 and older and 9.6% of children under 18 have a household income below poverty. ^[1] The Consolidated Plan and Annual Action Plan indicated that the City would support social services and housing activities for households living below the poverty line.

During the FY 20-21 reporting period, low-income seniors were assisted with CDBG-funded in-home support and case management services; these services were provided for free. The City also provided funding to Alzheimer's Orange County, which provided daycare services for seniors with Alzheimer's, dementia, or disabilities. The program offers a variety of medical, therapeutic, and social services for lower-income seniors. Because the City super-funded public service grants, these services also helped prevent, prepare for, or respond to the COVID-19 pandemic.

Recognizing that poverty-level households may need assistance affording food and health care, the City also provided financial assistance to nonprofits that provide primary health care and food bank services. Service providers also offered clients career counseling and computer training to help clients develop the skills and knowledge necessary for today's workplace.

In response to the economic impacts of the COVID-19 pandemic, the City provided significant CDBG-CV resources to help lower-income households maintain housing and utility services. According to program accomplishment data, 74.4% of CDBG-CV funded program beneficiaries are extremely low-income individuals. To assist local businesses equally impacted by COVID-19 stay-at-home and mandatory shut-down orders, the City developed two grant programs utilizing CDBG and CDBG-CV funds. Grants up to \$1,000 were provided to local businesses the created or retained employment opportunities for lower-income employees. Use of funds was limited to purchasing PPE or paying in-arrears rent or utilities needed to comply with public health and safety requirements to reopen or remain open – 80 businesses were assisted during the reporting period. A second business assistance program was also developed using CDBG funds; however, to facilitate the efficient use of HUD funds, the City Council authorized substituting CDBG-CV Round 3 funds for this purpose. City staff is evaluating modifications to the program, intending to provide impactful assistance to local businesses.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

During FY 20-21, the City continued efforts to eliminate institutional gaps and enhance program coordination with all community segments. For example, the City partnered with nonprofit entities to deliver public services. City departments also continued to work together to evaluate projects funded in

whole or in part with CDBG funds that address priority needs. The City assisted OCHA by participating in the Cities Advisory Committee – a quarterly meeting of municipal and OCHA staff to discuss federal rental housing assistance and regional housing issues. The City also provided critical information and support for the regional Continuum of Care (CoC) as it prepares the County's CoC Homeless Assistance grant application for HUD consideration. The City also supported efforts to develop the County's Ten-Year Plan to end chronic homelessness and a regional discharge plan. Finally, the City participated in meetings with other Orange County grantees to coordinate the preparation of the 2020-2024 Orange County Analysis of Impediments to Fair Housing for a new five-year cycle.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

As indicated above, the City participated in regional coordination of services by participating in the quarterly Cities Advisory Committee held by OCHA to discuss federal rental housing assistance and as a member of the Orange County CoC Forum. The City has partnered with local nonprofit housing providers to expand affordable housing opportunities for lower-income households in the past years.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

Consolidated Plan regulations require CDBG recipients to (1) examine and attempt to alleviate housing discrimination within their jurisdiction; (2) promote fair housing choice for all persons; (3) provide opportunities for all persons to reside in any given housing development, regardless of race, color, religion, sex, disability, familial status, or national origin; (4) promote housing that is accessible to and usable by persons with disabilities; and (5) comply with the non-discrimination requirements of the Fair Housing Act. HUD encourages jurisdictions to consult with one another and initiate countywide fair housing planning. The **Analysis of Impediments to Fair Housing Choice (AI)** is the primary document utilized for this purpose. Consistent with HUD's directive, the City partnered with 19 Orange County jurisdictions to prepare a countywide AI. The AI provides an overview of fair housing impediments throughout Orange County and in Lake Forest. The AI also includes an action plan to address regional and local fair housing impediments. **Attachment 3** summarizes the steps taken by the City and the Fair Housing Council of Orange County to address fair housing impediments during FY 20-21.

The City's CDBG monitoring program is designed to provide program staff with information necessary to verify the accuracy of data supplied by sub-recipients, ensure that sub-recipients are carrying out individual activities as described in their contracts, and ensure sub-recipients use appropriate accounting and record-keeping methods as it relates to the use of CDBG funds. Program policies ensure sub-recipients receive training regarding CDBG grant management, including the following topics: 1) review CDBG program goals, objectives, and sub-recipient obligations; 2) review the content of the sub-recipient agreements; and 3) review regulations related to the CDBG program that impact sub-recipients and the implementation of their programs.

On-site monitoring of sub-recipients is typically conducted biennially unless program or administrative issues are identified or the grant recipient is new to CDBG. The City intended to conduct sub-recipients on-site monitoring during the FY 20-21 reporting period; however, the monitoring was postponed due to the COVID-19 pandemic. As an alternative, staff conducted desk reviews of accomplishment reports and expenditure reports as a means to confirm program compliance. Assuming are return to normalcy, monitoring will be carried out in FY 21-22.

During the reporting period, program staff worked closely with City departments to ensure CDBG program regulations and other federal requirements were implemented. City departments and public service grant sub-recipients submitted accomplishment reports. Sub-recipients are required to provide documentation to support CDBG reimbursement requests.

The City also made every effort to comply with all CDBG and Consolidated Plan regulations. The City's Citizen Participation Plan ensures that community input is considered before submitting a substantial amendment or an annual update to HUD. It also provides residents the opportunity to review and comment on yearly performance. Construction, professional service, and sub-recipient agreements have been prepared to ensure compliance with applicable federal regulations. Additionally, the City has implemented an open procurement process that encourages bidding from minority and women-owned businesses.

Describe the efforts to provide citizens with reasonable notice and an opportunity to comment on performance reports.

The City published a notice in the Saddleback Valley News on September 2, 2021, announcing a 15-day public comment period and City Council meeting to encourage resident participation. The 2020-2021 CAPER was available for public review and comment from September 3, 2021, through September 17,

2021, online and at Lake Forest City Hall, located at 100 Civic Center. The Lake Forest City Council accepted additional public comments at its September 20, 2021, meeting. A copy of this notice and a summary of public comments is provided as **Attachment 4**.

Consistent with HUD guidance, on May 19, 2020, the City amended the 2019-2020 Annual Action Plan to accept and allocate Round 1 CDBG-CV funds authorized under the CARES Act of 2020. CDBG-CV funds must be used to prevent, prepare for, and respond to the Coronavirus pandemic. Funds were allocated to assist local businesses impacted by stay-at-home orders and social service agencies that help CDBG-eligible households affected by the Coronavirus.

In July 2021, the City Council approved a second substantial amendment 2019-2020 Annual Action Plan to accept and allocate Round 3 CDBG-CV funds. Cumulatively, the City will receive \$862,153 in CDBG-CV funds. The City took additional actions during the reporting period to facilitate and streamline the use of CDBG-CV funds to respond to the COVID-19 pandemic.


