
The maximum area for this sign type is 12 square feet, this sign type can be 2 ft. maximum height by a length to equal 12 sq.ft. OR 12 ft. maximum width by a height to equal 12 sq.ft.. This sign type shall occur as shown in elevation. The copy shall be limited to company name in project or corporate letter style. Logos 24" max height (three colors max.) may be permitted upon approval from Property management or its Designee. Only one sign will be permitted per north elevation, per tenant within tenants lease line. Letters or logos must be located in the allowed sign area (dashed box in elevation).

Option #1 (Non Illuminated): Individual reverse pan channel letters, 3" deep, fabricated from .063 aluminum with .090 aluminum faces. Paint edges white and faces painted black. Pin mount 1/2" off wall.

Option #2 (Internally Illuminated): Individual reverse pan channel letters, 3" deep, fabricated from .063 aluminum with .090 aluminum faces. Paint edges white and faces painted black. Halo Internal neon or L.E.D. illumination. Pin mount 1/2" off wall.

SIGN TYPE B2 ON-BUILDING / OWNER I.D. SIGN


The maximum area for this sign type is 36 square feet, this sign type can be 2 ft. maximum height by a length to equal 36 sq.ft. OR 18 ft. maximum width by a height to equal 36 sq.ft. This sign type shall occur as shown in elevation. The copy shall be limited to company name in project or corporate letter style. Logos 36" max height (three colors max.) may be permitted upon approval from Property management or its Designee. Only one sign will be permitted per north elevation, per tenant within tenants lease line. Letters or logos must be located in the allowed sign area (dashed box in elevation).

Option #1 (Non Illuminated): Individual reverse pan channel letters, 3" deep, fabricated from .063 aluminum with .090 aluminum faces. Paint edges white and faces painted black. Pin mount 1/2" off wall.

Option #2 (Internally Illuminated): Individual reverse pan channel letters, 3" deep, fabricated from .063 aluminum with .090 aluminum faces. Paint edges white and faces painted black. Halo Internal neon or L.E.D. illumination. Pin mount 1/2" off wall.


SIGN TYPE B3 - Single-Tenant On-Building / Tenant/Owner I.D. Sign

The maximum area for this sign type is 36 square feet with a 42" maximum height and 10' maximum width. This sign type shall occur at the concrete spandrel as shown (centered) in elevation, but not within 10' of building address. The copy shall be limited to company name in project or corporate letter style. Logos (three colors max.) may be permitted upon approval from Foothill Business Park Owners Association or it's Designee. Two signs will be permitted per owner. One sign over entry and one on secondary elevation as shown on site map. Letters or logos may not be located closer than one half of the letter height to any building edge or architectural feature.

Option #1 (non-illuminated) Individual cut out dimensional letters and graphics fabricated from aluminum or acrylic materials. All letters and graphics to be pin mounted off wall 1/4".

Option #2 (Internally Illuminated) Individual standard pan channel letters, 5" deep, fabricated from minimum .040 aluminum with minimum 1/8" thick acrylic faces affixed to channel using 3/4" trim cap. Internal neon or L.E.D. illumination. Pin mount 1/4" off wall.


SIGN TYPE B4 - Multi-Tenant On-Building / Tenant/Owner I.D. Sign

The maximum area for this sign type is 36 square feet with a 42" maximum height and 10' maximum width. This sign type shall occur at the concrete spandrel as shown (centered) in elevation, but not within 10' of building address. The copy shall be limited to company name in project or corporate letter style. Logos (three colors max.) may be permitted upon approval from Foothill Business Park Condo Owners Association or it's Designee. Two signs will be permitted per owner. One sign over entry and one on secondary elevation as shown on site map. Letters or logos may not be located closer than one half of the letter height to any building edge or architectural feature.

Option #1 (non-illuminated) Individual cut out dimensional letters and graphics fabricated from aluminum or acrylic materials. All letters and graphics to be pin mounted off wall 1/4".

Option #2 (Internally Illuminated) Individual standard pan channel letters, 5" deep, fabricated from minimum .040 aluminum with minimum 1/8" thick acrylic faces affixed to channel using 3/4" trim cap. Internal neon or L.E.D. illumination. Pin mount 1/4" off wall.

GRAPHICS ON GLASS

PROHIBITED SIGNS AND SIGN RESTRICTIONS As per city code Section 9.164.080 Prohibited Signs.

All signs that are not expressly permitted under this chapter or exempt from regulation hereunder in accordance with the previous article shall be prohibited in the City of Lake Forest. Such signs include:

A. Signs on public property except those serving a public purpose and approved by a government agency.

B. Signs in public rights-of-way* except those needed for traffic safety regulation, signs providing public information, and except as permitted according to the provisions under signs permitted in all districts as approved by planning commission.

C. Any offsite or outdoor advertising sign or structures, such as billboards or snipe signs, placed for the purpose of advertising a business not on the property upon which the sign is placed.

D. Banners, flags, kites, pennants, balloons, or other such advertising devices or displays, except as permitted according to the provisions under signs permitted in residential districts and special signs permitted in commercial and industrial districts.

E. Signs which revolve, rotate, move, flash, reflect, blink, or appear to do any of the foregoing, including searchlights, and animated signs shall be permitted in residential districts and special signs permitted in commercial and industrial districts.

F. Electronic message board signs, except those which display time and temperature.

G. Signs which constitute a nuisance or hazard due to their intensity of light.

H. Animals or human beings, live or simulated, designed or used so as to attract attention to the premises.

I. Loudspeakers or signs which emit sound, odor, or visible matter, except as provided within this sign ordinance.

J. Roof signs.

K. Abandoned signs.

L. Vehicle signs, including signs attached by any means to automobiles, trucks, trailers, or other vehicles on private or public property for the purpose of advertising, identifying, or providing direction to a use or activity not related to the lawful use of the vehicle for rendering service or delivering merchandise, that remain unmoved for four or more hours, as per this code.

M. Neon signs/bands in residential areas, and neon bands exceeding two hundred (200) percent of the lineal frontage of a building.

N. Portable signs.

O. Pole signs.

P. Signs that create hazards.

Q. Signs advertising or displaying any unlawful act, business or purpose.

* That is, on fire hydrants, traffic signs, or traffic signals, or so as to obscure fire hydrants, traffic signs, or traffic signals, to block motorist's line of sight, or to otherwise inhibit or interfere with vehicular or pedestrian traffic.
