A INTRODUCTION

The intent of this sign criteria is to provide the guidelines necessary to achieve a visually coordinated, balanced and appealing sign environment, harmonious with the architecture of the project, while maintaining provisions for individual graphic expression.

Performance of this sign criteria shall be rigorously enforced and any nonconforming sign shall be removed by the tenant or his sign contractor at their expense, upon demand by the Landlord.

Exceptions to these standards shall not be permitted without approval from the Landlord and will require approval of a modification to the sign program application by the City.

Accordingly, the Landlord will retain full rights of approval for any sign used in the center.

No sign shall be installed without the written Landlord approval and the required City permits.

LANDLORD/TENANT REQUIREMENTS

- 1. Each Tenant shall submit to Landlord for written approval, three (3) copies of the detailed shop drawings of this proposed sign, indicating conformance with the sign criteria herein outlined.
- 2. The Landlord shall determine and approve the availability and position of a Tenant name on any monument sign(s).
- 3. The Tenant shall pay for all signs, related materials and installation fees (including final inspection costs).
- 4. The Tenant shall obtain all necessary permits.
- 5. The Tenant shall be responsible for fulfillment of all requirements of this sign criteria.
- 6. It is the responsibility of the Tenant's sign company to verify all conduit and transformer locations and service access prior to fabrication.
- 7. Should a sign be removed, it is the Tenant's responsibility to patch all holes, paint surface to match the existing color, and restore surface to original condition.
- 8. All signs, including temporary banners, must be permitted by the City prior to installation.

















GENERAL SIGN CONSTRUCTION REQUIREMENTS:

- 1. All signs and their installation shall comply with all local building and electrical codes.
- 2. All electrical signs will be fabricated by a U.L. approved sign company, according to U.L. specifications and bear U.L. Label. U.L labels are to be placed in an inconspicuous location, out of view from normal viewing angles.
- 3. Sign company to be fully licensed with the City and State and shall have full Workman's Compensation and general liability insurance.
- 4. All penetrations of building exterior surfaces are to be sealed waterproof in color and finish to match existing exterior.
- 5. Painted surfaces to have a satin finish. Only paint containing acrylic polyurethane products may be used.
- 6. Logo and letter heights shall be as specified and shall be determined by measuring the normal capital letter of a type font exclusive of swashes, ascenders, and descenders.
- 7. All sign fabrication work shall be of excellent quality. All logo images and type-styles shall be accurately reproduced. Lettering that approximates type-styles will not be acceptable. The Landlord reserves the right to reject any fabrication work deemed to be below standard.
- 8. All lighting must match the exact specification of the approved working drawings. No exposed conduits will be allowed.

- 9. Signs must be made of durable rust –inhibiting materials that are appropriate and complimentary to the building.
- 10. Color coatings shall exactly match the colors specified on the approved plans.
- 11. Joining of materials (e.g., seams) shall be finished in way as to be unnoticeable. Visible welds shall be continuous and ground smooth. Rivets, screws, and other fasteners that extend to visible surfaces shall be flush, filled, and finished so as to be unnoticeable.
- 12. Finished surfaces of metal shall be free from oil canning and warping. All sign finishes shall be free from dust, orange peel, drips, and runs and shall have a uniform surface conforming to the highest standards of the industry.
- 13. In no case shall any manufacturer's label be visible from the street from normal viewing angles.
- 14. Exposed junction boxes, lamps, tubing or neon crossovers of any type are not permitted.
- 15. Window signage is permitted per City code Section 9.164.090C(17). which allows 4 square feet of window signage. If additional window signage is being requested, justification to the City must be provided.





SHOP TENANT SIGNAGE SPECIFICATIONS:

The intent of this criteria is to insure a standardized uniform style throughout the center while encouraging the creativity of typographical and iconic elements to develop interest and style. Signs must be architecturally compatible with the entire center.

Per the City sign code 9.164.040:

A. Height of a Sign. The height of a sign shall be computed by measuring the vertical distance from the midpoint, or average ground level, along the base of the sign structure, excluding any berming, to the highest point of the structure.

B. Distinct Border or Boundary. For signs with a distinct border or boundary, the sign area shall be computed by multiplying the length times the width of the entire surface within the border, boundary, sign board, or sign face.

C. No Distinct Border or Boundary. For signs with no distinct border or boundary, the sign area shall be calculated by computing the area of a simple rectilinear figure, consisting of not more than eight (8) perpendicular lines, which contains all of the writing, representation, emblem, or other display on such sign.

Per the Planning Commission staff report, the maximum letter/logo height of all wall signs (major and non-major tenants) is established by the Sign Code. Refer to LFMC Section 9.164.090.C for the allowable letter/logo heights.

PROHIBITED SIGNS:

PER CITY CODE 9.164.080

All signs that are not expressly permitted under this chapter or exempt from regulation hereunder in accordance with the previous section shall be prohibited in the City. Prohibited signs include:

A. Signs on public property except those serving a public purpose and approved by a government agency;

B. Signs in public street rights-of-way*, except those needed for traffic safety regulation, signs providing public service information, and except as permitted according to the provisions under signs permitted by the Planning Commission;

C. Any off-site or outdoor advertising sign or structures, such as billboards or snipe signs, placed for the purpose of advertising a business not on the property upon which the sign is placed. This prohibition shall not apply to noncommercial signs, as defined in Section 9.164.030

D. Banners, flags, kites, pennants, balloons, or other such advertising devices or displays, except as permitted under Section 9.164.090(A) and Chapter 5.05 of the Lake Forest Municipal Code;

E. Signs which revolve, rotate, move, flash, reflect, blink, or appear to do any of the foregoing, including searchlights, and animated signs, unless required by law or utilized by a proper government agency;

F. Electronic message board signs;

G. Signs which constitute a nuisance or safety hazard due to their size or intensity of light or color;

H. Animal signs which display, offer for sale or vending, or otherwise make available any goods and/or products; or are used to attract attention to a premises;

I. Loudspeakers or signs which emit sound, odor, or visible matter, except as provided for within this Sign Ordinance;

J. Roof signs;

K. Abandoned signs;

All abandoned signs after 30 days will become the property of the Landlord and will be removed promptly.

L. Vehicle signs, including signs attached by any means to automobiles, trucks, trailers, or other vehicles on private or public property for the purpose of advertising, identifying, or providing direction to a use or activity not related to the lawful use of the vehicle for rendering service or delivering merchandise, that remain unmoved for two (2) or more hours, as per this code;

M. Neon signs/bands in residential areas; and neon bands in nonresidential areas, with the exception of neon used for limited accent colors;

N. Portable signs;

O. Pole and pylon signs;

P. Signs advertising or displaying any unlawful act, business or purpose;

Q. Cabinet signs, used as a main copy portion of the sign;

R. Signs with exposed or exterior raceways;

S. Human signs which display, offer for sale or vending, or otherwise make available any goods and/or products; or are used to attract attention to a commercial premises.

*That is, on fire hydrants, traffic signs, or traffic signals; or so as to obscure fire hydrants, traffic signs, or traffic signals, to block motorists' line of sight, or to otherwise inhibit or interfere with vehicular or pedestrian traffic.




■ SIGN CONSTRUCTION

Illuminated PLEX FACED CHANNELS with THROUGH FACE ILLUMINATION.


Use standard aluminum construction with Matthews (or equivalent) satin acrylic polyurethane finish.
Faces use any color of translucent Lexan with any color of trim cap. Illuminate with any color of LED's..
Paint aluminum channel any color.

NOTE: All signs may utilize digital vinyl printing on faces of illuminated or non illuminated surfaces.






Section 1

PLEX FACED CHANNEL LETTERS WITH LED ILLUMINATION






SITE PLAN


















