

# GRADING PERMIT APPLICATION

## OWNER-BUILDER DECLARATION

I hereby affirm under penalty of perjury that I am exempt from the License Law for the following reason (Sec. 7031.5, Business and Professions Code) Any city or county which requires a permit to construct, alter, improve, demo, repair any structure, prior to its issuance, also requires the applicant for such to file a signed statement that he or she is licensed pursuant to the provisions of the Contractors License Law (Chapter 9 (commencing with Sec. 7000) of Div. 3 Business and Professions Code) or that he or she is exempt therefrom and for the alleged exemption. Any violation of Sec. 7031.5 by any applicant for such subjects the applicant to a civil penalty of not more than five hundred dollars.

I, as owner of the property, or my employees with wages as their sole compensation, will do the work, and the structure is not intended or offered for sale.

I, as owner of the property, am exclusively contracting with licensed contractors to construct the project (Sec. 7044, Business and Professions Code). The Contractors License Law does not apply to an owner of property who builds or improves thereon, and who does work himself or herself or through his or her own employees, provided that improvements are not intended or offered for sale. If, however, the building improvement is sold within one year of completion, the owner-builder will have burden of proving that he or she did not build or improve for the purpose of sale.

I, as owner of the property, am exclusively contracting with licensed contractors to construct the project (Sec. 7044, Business and Professions Code). The Contractors License Law does not apply to an owner of property who builds or improves thereon, and who contracts for such projects with a contractor(s) licensed pursuant to the Contractors License Law.)
